FORMATION OF INTELLECTUAL POTENTIAL OF ENTERPRISES

- 2. The resource-based approach provides for the formation of intellectual potential as a set of intellectual resources of the enterprise (knowledge, abilities, software, information resources and intellectual property).
- 3. A functional approach provides for the formation of the intellectual potential as the opportunities available intellectual resources in a certain time in the future that can be used to achieve a certain goal
- 4. A synergistic approach provides for the formation of intellectual potential of an enterprise as a system with a high coefficient of tightness of the relationship.
- 5. Effective approach ensures the formation of the intellectual potential as the ability of intellectual resources to the tasks, including people, their knowledge, intellectual abilities, intangible assets, which characterize

the cumulative intellectual capacity, which can be used in the process of functioning of the economy.

Scientific approaches in its structure are not unambiguous and stable. They are determined by: degree of stability of enterprise structures, the dynamism of enterprise development, life cycles organization chosen by the model of functioning chosen development strategies, the development of a competitive environment, level of economic development systems, etc. In certain periods and in certain situations they may have a different direction of development. However, economic practice, argues that the high efficiency of enterprises achieved using a balanced system of scientific approaches [2].
